OFFICE MEMORANDUM

Subject: i) Compliance of price fixation of coronary stents and related issues.
ii) IPDMS for medical devices.

The undersigned is directed to inform that Government of India in the Ministry of Health and Family Welfare included Coronary Stents in the National List of Essential Medicines, 2015 (NLEM, 2015) by notification No X-11035/344/2015-DFQC dated 19th July 2016. Ministry of Chemicals and Fertilizers, Department of Pharmaceuticals, by notification No. S.O. 4100 (E) dated 21st December 2016 has incorporated Coronary Stents at serial no. 31 of Schedule I of the Drug Prices Control Order, 2013 (DPCO, 2013) and therefore, Coronary Stents are 'scheduled formulations' under the provisions of the DPCO, 2013. NPPA has fixed the ceiling prices of Coronary Stents with immediate effect vide its S.O. 412(E) dated 13th February 2017, in order to protect public interest.

In this matter is reference invited to Para (f) of S.O. 412(E) dated 13th February 2017 wherein it has been mentioned that the manufacturers under Paragraph 24 of DPCO, 2013 shall issue price list in Form-V as prescribed in Schedule II of the DPCO, 2013 to the NPPA online through Integrated Pharmaceutical Database Management System (IPDMS) and submit a copy to all State Drug Controllers and all distributors/dealers/retailers. They shall also furnish quarterly return to the NPPA, in respect of production / import and sale of Coronary Stents in Form-III as prescribed in Schedule-II of the DPCO, 2013 through IPDMS. User manual for filing requisite forms in IPDMS is available in the home page website of NPPA (<http://nppaindia.nic.in/nppareg/help.pdf>). It is further communicated that as coronary stents have been notified by Department of Pharmaceuticals as scheduled formulations, it is mandatory for all manufacturers/ importers/ marketers of coronary stents to file Form II (Copy enclosed) as prescribed in the DPCO, 2013, read with S.O No. 1910(E) dated 13.07.2015 in the Integrated Pharmaceutical Database Management System (IPDMS).

As the software of IPDMS for medical devices/ coronary stents is under development, all manufacturers//importers/ marketers of coronary stents are requested to submit the requisite information in Form V (format attached) to this office in hard copy and also in soft version (in

Excel format only) on email id nppa@nic.in , dir.me.nppa@gmail.com and me.nppa2015@gmail.com before 1st March 2017. Necessary action will be initiated as per provisions of DPCO 2013 read with Essential Commodities Act, 1955 against the company, if the requisite information is not submitted within the prescribed date.

Special interactive sessions will be held at the NPPA Conference Hall on 21st February 2017 at 12 noon and 04.00 PM to address the issues related to filing of the forms in IPDMS, price compliance in respect of coronary stents and other related issues. All manufacturers/ importers/ marketers of coronary stents are requested to send their authorized representatives for attending the special interactive sessions.
