The bids received without bid security will not be considered. **The last date of submission of bids is 29.07.2014.** The bids shall be opened on 30.07.2014 at 3.30 P.M. in the office of NPPA. The authorized representative of the firm may like to be present at the time of opening the bids. The highest bidder will be awarded the contract who will be required to deposit the entire bid amount in the form of DD in favour of PAO, Department of Pharmaceuticals, payable at New Delhi, and thereafter remove at its own cost the obsolete material from the office of NPPA within two working days of awarding contract. In case the successful bidder does not show interest in lifting the goods, the bids security will be forfeited and other actions as deemed fit will be taken against the bidder.
