6.1.1.2 The Authority deliberated upon the matter in detail and decided to accept the request of the applicant as a special case and approve the ceiling price of Tetanus Toxoid injection at Rs. 10.61 per 0.5 ml pack excluding GST and Tetanus Toxoid injection at Rs. 22.94 per 5 ml pack excluding GST towards implementation of the review order no. 31015/46/2018-Pricing dated 19.03.2019.
