Agenda No. I - Retail price fixation under Para 5 of DPCO, 2013 - Human Prothrombin Complex IP-250 IU in which each vial containing Human Coagulation Factor II 175-412 IU, Human Coagulation Factor VII 40-260 IU, Human Coagulation Factor IX 250 IU, Human Coagulation Factor X 150-530 IU, Protein C 230-450 IU, Protein S 220-440 IU, Heparin 15-30 IU, Total protein not more than 52g/l for M/s Intas Pharmaceuticals Ltd. 2.1 The Committee deliberated upon the matter in detail and recommended the retail price of Betadine Alcoholic Handrub in which each 100 ml contains Povidone Iodine IP 1.0g (Available Iodine 0.1 g) and 2-Propanol IP 50 mg for M/s Win Medicare Pvt. Ltd (marketer) and M/s G.S. Pharmbutor Pvt. Ltd (manufacturer/ importer). at Rs. 92.00 per 200 ml pack excluding GST as detailed below:

3.1 The Committee deliberated upon the matter in detail and recommended the retail price of Valera M 500 Tablet in which each film coated bilayer tablet contains Evogliptin Tartrate eq. to Evogliptin 5 mg and Metformin Hydrochloride IP 500 mg (as sustained release form) for M/s Alkem Laboratories Ltd. (marketer) and M/s Alkem Healthscience (manufacturer/ importer) at Rs. 17.11 per tablet excluding GST as detailed below:

(marketer/ importer)

4.1 The Committee deliberated upon the matter in detail and recommended the retail price of Amoxycillin and Potassium Clavulanate Oral Suspension IP in which Each 5 ml of the reconstituted suspension contains Amoxycillin Trihydrate (759.04 mg) eq. to Amoxycillin Free Acid 652.78 mg and Potassium Clavulanate (61.48 mg) eq. to Clavulanic Acid 50.41 mg (Brand name: Augmentin ES) for M/s GlaxoSmithKline Pharmaceuticals Ltd. (marketer/ importer) at Rs. 181.50 per 50 ml pack excluding GST as detailed below:

Derived Retail price for Amoxicillin 652.78mg/5ml Suspension =  $1.34[1+0.70\{652.78-250)/250\}]$  = Rs. 2.85 per ml

Calculation of price for Clavulanic Acid 50.41 mg suspension

Ceiling Price of Amoxycillin 200mg + Clavulanic Acid 28.50mg / 5ml dry syrup = Rs. 1.80 per ml

Less: Price of Amoxycillin 200mg / 5ml (Rs. 1.34/250\*200) = Rs. 1.07 per ml

- Price of Clavulanic Acid 28.50mg / 5ml dry syrup (Rs. 1.80-Rs. 1.07) = Rs. 0.73 per ml
- Derived Retail price for Clavulanic Acid 50.41mg dry syrup = 0.73[1+0.70{50.41-28.50}] = Rs. 1.12 per ml

## 5. Agenda no. 5 - Application for extension of ceiling price for Ringer lactate injection in packaging with special feature.

5.1 The Committee deliberated upon the matter in detail and noted that 2 companies namely, M/s Axa Parenterals Ltd and M/s Rusoma Laboratories Pvt. Ltd have applied for separate ceiling price for ringer lactate injection in packages with special features in line with S.O. 1216(E) dated 25.03.2020. The two companies made demonstration before the members. The Committee observed that the packages of ringer lactate injection of the two companies namely, M/s Axa Parenterals Ltd and M/s Rusoma Laboratories Pvt. Ltd have special features as (i) Self Collapsibility and self-seal ability, (ii)

not having air-vent and (iii) having no chance of contamination during manufacture / infusion / admixing levels. Accordingly, the Committee recommended to extend the ceiling prices and the formulations mentioned in SO. 1216(E) dated 25.03.2020 to the two companies namely, M/s Axa Parenterals Ltd and M/s Rusoma Laboratories Pvt. Ltd for ringer lactate injection for packages with special features.

# 6. Agenda no. 6 - Application for extension of ceiling price for I.V. Fluids with packaging in Non-glass with special feature.

6.1 The Committee deliberated upon the matter in detail and noted that one company namely, M/s Rusoma Laboratories Pvt. Ltd had applied for separate ceiling price for IV fluids with packaging in non-glass with special features in line with S.O. 1215(E) dated 25.03.2020. M/s Rusoma Laboratories Pvt. Ltd made demonstration before the members. The Committee observed that the non-glass packages of I.V. fluids of M/s Rusoma Laboratories Pvt. Ltd have special features as (i) Self Collapsibility and self-seal ability, (ii) not having air-vent and (iii) having no chance of contamination during manufacture / infusion / admixing levels. Accordingly, the Committee recommended to extend the ceiling prices and the formulations mentioned in SO. 1215(E) dated 25.03.2020 to M/s Rusoma Laboratories Pvt. Ltd for I.V. fluids in packages in non-glass with special features.

# 7. Agenda no. 7 - Application for upward price revision of Mannitol Injection 20% under para 19 of DPCO 2013 by Rusoma Laboratories Ltd

### 8. Agenda no. 8 - Ceiling Price fixation of Tetanus + Diphtheria (TD) Vaccine

8.1 The Committee deliberated upon the matter in detail and noted that as per explanation 3 of amended schedule-I of DPCO 2013, all available strength of TD vaccine be considered as scheduled formulations and recommended that separate ceiling price of TD vaccine for different strength may be fixed.
