<u>Sub: Submission of monthly stock related details for Oxygen Concentrators in pursuance to the Trade Margin Rationalization Notification dated 3rd June 2021 -reg.</u>

The Government vide Gazette Notification No. 2161(E) dated 3rd June 2021 has capped the Trade Margin for Oxygen Concentrators and revised MRPs for the same,in compliance to formula prescribed in the above mentioned notification, were issued on 9th June 2021. In the Notification under reference, it was further directed that manufacturers / importers of Oxygen Concentrators shall submit monthly stock details namely units manufactured, imported, sold and exported, in the prescribed format, in order to assess the availability of the same in the country.

2. In view of the above, manufacturers / importers of Oxygen Concentrators are hereby directed to submit requisite monthly stock details, starting from the month of May 2021, in the prescribed format (enclosed) within 15 days from the completion of the month till the time notification mentioned above is in force.
