

OFFICE MEMORANDUM

Sub: Submission of quarterly stock related details for (i) Pulse Oximeter, (ii) Blood Pressure Monitoring Machine, (iii) Nebulizer, (iv) Digital Thermometer & (v) Glucometer in pursuance to the Trade Margin Rationalization Notification dated 13th July 2021 -reg.

The Government vide Gazette Notification No. 2808(E) dated 13th July 2021 has capped the Trade Margin for the five (5) medical devices, namely, (i) Pulse Oximeter, (ii) Blood Pressure Monitoring Machine, (iii) Nebulizer, (iv) Digital Thermometer, (v) Glucometer. In the Notification under reference, it was further directed that manufacturers / importers of these five (5) medical devices shall submit quarterly stock details, including, units manufactured, imported, sold and exported, in the prescribed format, in order to assess the availability of the same in the country.


2. In view of the above, manufacturers / importers of these five (5) medical devices are hereby directed to submit requisite quarterly stock details, for every quarter, in the prescribed format (enclosed) within 10 days from the completion of the quarter till the time notification mentioned above is in force.


