**OFFICE MEMORANDUM**

**Sub: Regulation of Ceiling Prices of Orthopaedic Knee Implants for Knee Replacement System under Para 19 of the DPCO, 2013-reg.**

The undersigned is directed to refer to the Gazette Notifications No. S.O. 3147(E) dated 15<sup>th</sup> September 2020 issued by National Pharmaceutical Pricing Authority (NPPA) regarding fixation/revision of ceiling prices of the orthopedic Knee Implants for Knee Replacement System issued under Para 19 of the DPCO, 2013 wherein it has been notified that the ceiling prices as applicable to the orthopedic Knee Implants for Knee Replacement System as on 15<sup>th</sup> September, 2020 are hereby extended up to 15<sup>th</sup> September, 2021.

2. In this connection, NPPA has received requests from various quarters to clarify the aforesaid Order with regard to increase in price. Thus, it is hereby clarified that no increase in ceiling prices have been allowed for the year 2020-21 and the ceiling prices as applicable on 15<sup>th</sup> September 2020 have been further extended for the period of another one year upto 15<sup>th</sup> September 2021.

3. In view of the above, it has been decided to publish the applicable maximum prices allowed for orthopedic Knee Implants for Knee Replacement System for the period from 16<sup>th</sup> September 2020 to 15<sup>th</sup> September 2021 for further clarity in the matter. Accordingly, the applicable ceiling prices for orthopedic Knee Implants for Knee Replacement System for the above mentioned period is provided in Annexure-I.




4. It is also reiterated that any manufacturer or institution or person not complying with the ceiling prices regulated under Para 19 of the DPCO, 2013 shall be liable to deposit the overcharged amount along with interest thereon under the provisions of the Drugs (Prices Control) Order, 2013 read with Essential Commodities Act, 1955.
