The undersigned is directed to refer the Office Memorandum dated 13th March 2020 issued by this office on the captioned subject regarding submission of information pertaining to Masks, Gloves and Hand Sanitizers in the prescribed format.

- 2. In this connection, it has been observed that very few manufacturers/importers have submitted the requisite information in the prescribed format. It is, therefore, informed to all the companies concerned that non-compliance of the Orders issued by this office would attract penal provisions of the DPCO, 2013 and the Essential Commodities Act, 1955 which may lead to Search and Seizure and even prosecution for defaulting companies.
- 3. All manufacturers/importers are hereby directed to submit the requisite details in the prescribed format within 24 Hrs. to this office latest by 6 PM on 18th March 2020 failing which NPPA would be constrained to initiate appropriate coercive action.
