1. Limited Tender Enquiry (LTE) under Government Financial Rules, 2017 on Central Public Procurement Portal

- National Pharmaceutical Pricing Authority (NPPA) invites agencies/ companies registered with National Informatics Centre Services Inc. (NICSI), (Category: TIER-III) having capacity and proven track record of providing Annual Maintenance Contract (AMC) for management of Government Websites, to submit their Financial Bids against this Limited Tender Enquiry (LTE).
- II. Interested Agencies/ Companies, who meet the Eligibility Criteria, may furnish their Financial Bid against this LTE, along with all the necessary documents and the covering letter, each page duly signed and stamped by an authorized signatory, shall be uploaded on the Central Public Procurement Portal of Government of India (<u>https://eprocure.gov.in/eprocure/app</u>) on or before 8th February, 2021 by 16:00 Hrs.
- III. The Financial Bid submitted by fax / e-mail, etc., shall not be considered. No further correspondence on the subject will be entertained.

2. INTRODUCTION

- a. National Pharmaceutical Pricing Authority (NPPA), an independent body of experts in the Ministry of Chemicals and Fertilizers was constituted by the Government. of India vide Resolution published in the Gazette of India No. 159 dated 29.08.97. The functions of NPPA, inter-alia, include fixation and revision of prices of scheduled formulations and scheduled Medical Devices under the Drugs (Prices Control) Order (DPCO), as well as monitoring and enforcement of prices of Scheduled and Non-scheduled formulations and Medical Devices. NPPA also provides inputs to Government on pharmaceutical pricing policy and issues related to affordability, availability and accessibility of medicines and medical devices. Information regarding activities undertaken by NPPA is available on the website of NPPA.
- b. Functions of National Pharmaceutical Pricing Authority
 - I. To implement and enforce the provisions of the Drugs (Prices Control) Order in accordance with the powers delegated to it.
 - 2. To deal with all legal matters arising out of the decisions of the Authority.
 - 3. To monitor the availability of drugs including medical devices, identify shortages, if any, and to take remedial steps.
 - 4. To collect/ maintain data on production, exports and imports, market share of individual companies etc., for bulk drugs and scheduled formulations.
 - 5. To undertake and/ or sponsor relevant studies in respect of pricing of drugs/ pharmaceuticals.
 - 6. To recruit/ appoint the officers and other staff members of the Authority, as per rules and procedures laid down by the Government.
 - 7. To render advice to the Central Government on changes/ revisions in the drug policy.
 - 8. To render assistance to the Central Government in the parliamentary matters relating to the drug pricing

3. THE PURPOSE

NPPA intends to invite Limited Tender Enquiry on CPPP Portal from the NICSI empanelled (TIER-III) IT Companies/Agencies to provide annual maintenance and security related services for the websites owned by National Pharmaceuticals Pricing Authority through under the provisions of General Financial Rules, 2017 issues by the Ministry of Finance, Government of India.

4. CRITICAL INFORMATION

Submission of Financial Bids in response to this LTE shall be deemed to have been done after careful study and examination of this document with full understanding of its terms, conditions and implications.

- b. After limited sharing of the LTE to all the empanelled TIER-III companies with NICSI, all queries received shall be responded promptly.
- c. NPPA makes no representation or warranty as to the completeness or accuracy of any response made in good faith, nor does NPPA undertake to answer all the queries that have been posed by the Bidders.
- d. The responses to all the queries from all Bidders will be replied individually though e-mail/ or by Post within the stipulated time frame.
- e. At any time prior to the last date for receipt of LTE, NPPA may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the LTE document by issue of corrigendum(s) through e-mail/post to the companies to whom invitation for LTE has been sent.
- f. Any such corrigendum(s) shall be deemed to be incorporated into this LTE.
- g. In order to provide prospective bidders reasonable time for taking the corrigendum(s) into account, NPPA may, at its discretion, extend the last date for the receipt of LTE which shall be intimated through e-mail/post to the companies to whom invitation for LTE has been sent.

8. SUBMISSION OF BIDs

A. Financial Bid

- a. The interested Bidders shall submit Financial Bid on Central Public Procurement Portal of Government of India (<u>https://eprocure.gov.in/eprocure/app</u>) and will complete all the formalities/process mentioned for the same.
- b. Financial Bid should contain only the total annual cost of the work, clearly broken into charges of the agency for the work and taxes (rate and amount).

B. Validity of Offer:

The offer submitted under the Bid in response to this LTE shall be valid for a period of three (3) months.

9. BID PREPARATION COSTS & RELATED ISSUES

- a. The Applicant is responsible for all costs incurred in connection with participation in this process, including, but not limited to, costs incurred in preparation of proposal, participation in pre-bid meetings/ discussions, opening of bids, etc., if any. NPPA in no case will be responsible or liable for these costs, regardless of the conduct or outcome of the LTE process.
- b. This LTE does not commit NPPA to award a contract or to engage in further process.
- c. All documents/ materials submitted by the Applicants will become the property of NPPA.

10. PAYMENT TERMS

- a. Payment for the work shall be made on quarterly basis, upon submission of the bills for a quarter in the subsequent quarter.
- b. The payment shall be subject to satisfactory performance of the agency.

II. GENERAL CONDITIONS

a. Disqualifications:

NPPA may, at its sole discretion and at any time during the evaluation process, disqualify any agency, if the agency has:

- i. Submitted the proposal/ documents after the due date;
- ii. Made misleading or false representation in the forms, statements and attachments submitted in proof of the eligibility requirements;
- iii. Exhibited a record of poor performance such as abandoning works, not properly completing the contractual obligations, inordinately delaying completion or financial irregularities, etc. in any project of any organization of Government of India or State Government in the preceding three year;
- iv. Submitted a proposal that is not accompanied by required documentation or is non-responsive;
- v. Failed to provide clarifications related thereto, whenever sought;
- vi. Submitted more than one Proposal;
- vii. Declared ineligible by any organization of the Government of India or State Government for corrupt and fraudulent practices or blacklisted for any reasons;
- viii. Submitted a conditional proposal.
- b. NPPA reserves the right to accept or reject any or all the bids without assigning any reason thereof.
- c. NPPA intends to award the AMC contract for NPPA websites for on yearly basis for maximum of 3 years subject to satisfactory performance of the selected Bidder.
- d. NPPA may short close the AMC contract with prior Notice of 30 days without assigning any reason for the same.
- e. All the documents/information asked in this Bid shall be duly signed by the authorized representative and shall be submitted over CPPP Portal within the stipulated time frame.
